WSO-CSI, WSO-CSI(SL), WSO-CSI(ML)

The WSO Symposium is a perfect platform for obtaining a WSO certification! If you are a WSO-CSI certification candidate, or if you already hold the WSO-CSI or WSO-CSI(SL) and would like to upgrade to WSO-CSI(ML), we invite you to take advantage of this opportunity to have your presentation evaluated at this year's Symposium! WSO-Certified Safety Instructor Basic Level, WSO-CSI

This basic certification deals with the elementary aspects of instruction. This includes: basic public speaking, use and control of audiovisual aids, handling distractions and difficult students. (two (2) years verifiable instructor experience.)

WSO-Certified Safety Instructor Senior Level, WSO-CSI(SL)

This program identifies and requires demonstrated proficiency in four types of presentations: formal briefing, informal briefing; verbal report, and classroom instruction. Additionally, development and preparation of audio-visual aids and "class action synergy" will be stressed. (four (4) years of verifiable instructor experience.)

WSO-Certified Safety Instructor Master Level, WSO-CSI(ML)

This highest level of certification requires demonstrated proficiency in program development, presentation, media choice, points for documentation and paper publishing, and continuity. (six (6) years of verifiable instructor experience.)

Application Requirements

- Candidate must be a current Affiliate Member of the WSO, be of good moral character, meet application requirements, satisfy the educational and experience criteria, pay the required fee and pass the required evaluation. All applications for certification shall be on forms prescribed and furnished by the Board. Processing shall conform with procedures prescribed by the Board.
- Candidate, seeking certification as a Certified Safety Instructor (any level) must have at least five years of verifiable experience in the field of Occupational Safety and Health, Environmental Safety and Health, or specialized allied area, i.e.: Nuclear Safety, Emergency Response, Aviation Safety, Vehicular/Fleet Safety, Ergonomics, Industrial Hygiene, Emergency Management, Maritime Safety, Hazardous Materials Management, Industrial Safety,

- Chemical Safety, Process Safety Management, Systems Safety, Product Safety, Construction Safety, etc.
- Candidate must hold one of the WSO Professional Certifications (WSO-CSE, -CSM, -CSS, or -CSSD) or current certification from other certifying groups deemed acceptable to the WSO Certification Board. If Candidate does not hold such a certification, he/she must pass one of the written examinations currently in use for WSO professional certifications with a score of 75% or better.
- All levels require classroom instruction and demonstrated proficiency in an approved Project Presentation (for first two levels this may be a video presentation that is sent in for evaluation).
- Presentation must be in English language.

The Master Level requires a graded program proposal, acceptance and development, coupled with a performance presentation at an annual WSO Conference.

All three levels require an overall score of 80% from the Review Board for the successful assessment of the presentation by the Review Board.

An application package must contain the following:

- 1. Professional recommendations (Candidate Evaluation forms) by at least 2 supervisory personnel and 2 persons who have received training from the certification applicant.
- 2. Skills demonstration as verified by personal presentation and a video presentation judged appropriately by a Verification Committee consisting of at least three WSO members holding academic degrees, a professional certification and recognized by the WSO Certification Board as having personal skills and demonstrated proficiency in the area of student training and program development. Personal and video presentation must be in English language.
- 3. Development and presentation of an accepted paper/ program at an annual WSO conference or program with recommendations from the Verification Committee.
- 4. Applicant must be an Affiliate Member of the WSO.

Other WSO Certifications Available for Testing at Symposium

Entry Level Certification WSO-CST

WSO-Certified Safety Technician (WSO-CST)

WSO-CST is an entry level designation for specialists in safety related disciplines, i.e.: fire science, industrial hygiene, occupational safety and health, nuclear safety, loss control, etc. (This designation is not a prerequisite for other WSO professional certifications.)

Application Requirements

An applicant must be a current WSO Affiliate Member, be of good moral character, meet application requirements, satisfy the educational and experience criteria, and submit the required membership fees. All applications for certification shall be on forms prescribed and furnished by the Board. Processing shall conform with procedures prescribed by the Board.

General Requirements

- A Bachelor degree in Safety or associated discipline and current employment in a safety position; or
- An Associate degree in Safety or an associated discipline, three years field experience in safety, and currently employed in a safety position; or
- 3. Five years field experience in safety or associated discipline and currently employed in a safety position.

Special Requirements

- The applicant must be an affiliate member of the WSO.
 The applicant must complete an Application for Certification form and provide two "Candidate Evaluations" from individuals familiar with applicant's work in safety. Individuals just completing college or university degree programs must provide recommendations from two of their instructors/professors.
- Applicant wishing to advance to WSO-CSE, WSO-CSM, WSO-CSS, WSO-CSSD must agree to complete at least one WSO approved safety course or training program (or approved equivalent) per year for a period of five years and then take the examination for the professional certification no later than one year after the completion of the last training course/program.
- 3. Applicants must agree to abide by the code of professional ethics followed by all certified members of the WSO.

WSO Professional Certification Categories WSO-CSE, WSO-CSM, WSO-CSS, WSO-CSSD

WSO -Certified Safety Executive, WSO-CSE

A safety practitioner in an executive position in a corporation, company, government office or other entity, who has in-depth knowledge of safety programs, procedures, and activities, and is responsible for the establishment of safety policies, programs and methods for the organization or entity by who the individual is employed. This individual will utilize knowledge learned from various educational sources plus competencies acquired from training and professional experiences to prevent, minimize or control hazards and risks that threaten people, resources, and the environment.

WSO-Certified Safety Manager, WSO-CSM

A safety practitioner who accomplishes the supervision and management work of safety activities at the middle manager's level. He/she enforces policies and safety programs, supervises training, and occasionally performs functions of a technical nature in the safety field. He/she is responsible for the coordination of safety programs with all elements of an organization in order to secure the most effective results through and with other people. He/she is responsible for suggesting program or policy changes as they pertain to safety. Under crisis conditions, he/she will develop and implement special programs as the situation requires. He/she must have adequate knowledge and expertise in both management and safety to accomplish his/her mission.

WSO - Certified Safety Manager (Construction), WSO-CSM (Construction)

This designation is very similar to the regular WSO-CSM; however the WSO reached out to the construction industry with this certification to provide credentialing for those with accumulated years of safety experience in the highly specialized field of Construction Safety. The WSO-CSM for Construction exam is specifically designed for construction work, rather than predominantly General Industry and Maintenance covered by/under the WSO-CSM.

WSO-Certified Safety Specialist, WSO-CSS

A safety practitioner who specializes in a specific area in the safety profession. The concentration must be in a definite area

such as fire safety, transportation safety, nuclear safety, hazardous materials, product safety, health care safety, electrical safety, oil well drilling & servicing, ladder safety etc. He/she must be able to perform both the technical and management work of safety in his/her respective

field in order to secure the most effective results through and with other people. He/she performs all of the technical and management work required of the safety position.

WSO-Certified Safety and Security Director, WSO-CSSD

An individual responsible for the safety and security of people, property, resources or environment or any single segment or combined segments thereof. Security must be one of the segments. This individual will utilize knowledge, skills, training and expertise learned from various educational sources plus competencies acquired from actual work and field experiences to prevent or control hazards, potential losses and risks. The applicant must be proficient in the professional skills required in the security profession and have the basic knowledge to cope with and handle any risks in the areas of safety.

Certification Requirements

An applicant must be a current Affiliate Member of the WSO, be of good moral character, meet application requirements, satisfy the educational and experience criteria, pay the required fees, and pass the written examination.

Application Requirements

All applications for certification shall be on forms prescribed and furnished by the WSO Certification Board. Processing shall conform with procedures prescribed by the WSO Certification Board. All applicants must be affiliate members of the WSO. He or she must fill out the application for certification, have two "Candidate Evaluations" from individuals familiar

with the applicants safety* experience, and a current resume must be submitted to the WSO Certification Board.

Experience Requirements

An applicant must have at least ten years of professional safety experience, or a combination of education and experience to equal 10 years (see below for education equivalents).

Experience Requirements/Equivalents

- A Candidate for certification with a Bachelor's degree is equivalent to 4 years of the experience requirements. The degree should be in safety, i.e., physical sciences, engineering, safety management, security, or other curricula acceptable to the WSO Certification Board.
- 2. A Master's degree acceptable to the WSO Certification Board may be recognized as equivalent to two additional years of professional safety* work.
- 3. A Doctorate degree, acceptable to the WSO Certification Board, may be recognized as equivalent to three additional years of safety* experience.
- 4. Relevant professional licensing, certification or registration may be recognized by the WSO Certification Board as equivalent for up to two years of professional experience.

The above experience equivalents shall be acceptable at the highest level and shall not be cumulative.
