# WSO Environmental/Occupational Safety Person of the Year

*Criteria for Nomination*: Individual who has shown above-average support and dedication to the protection of people, property, resources, and the environment on an international basis, fulfilling at least three of the following requirements (may be retired, does not have to be practicing full time in the safety profession at the time of nomination): • can document continuous involvement in safety or allied profession for a period of at least 10 years • participated in a significant manner in the safety discipline work in at least five countries worldwide • authored book(s)/articles in his/her field of expertise, significant in nature, published in at least five countries upport for the promotion of safety education and discipline • other significant accomplishments may be submitted for review.



#### Janis Jansz MPH, PhD, FSIA, FSIWA

Senior Lecturer OHSE, Curtain University, Bentley, Western Australia; Adjunct Senior Lecturer, School of Business and Law, Edith Cowan University, Joondalup, Western Australia

Dr. Janis Jansz has pioneered providing educational and networking opportunities for World Safety Organization members in Australia and in other countries. Mr. Glenn "Ricky" Simpson sought ways to make accessing ECMD's Safety Data System more convenient through innovated ways that were well-appreciated by their employees, managers, and even stakeholders outside of their company. This practice that Mr. Simpson introduced is truly worthy of commendation as this reduced cost to a great extent while improving the productivity rate of its employees. In addition to this, he also coordinated a facility maintenance database with the assistance of the company's MIS department to maintain up-to-date data involving environmental permits. This effort reduced cost and time ensuring proper scheduling, etc. Safety and Health programs, training, training videos, and documentation forms were being provided to employees, supervisors, and management. This development enabled up-to-date, consistent information being provided to the company's ten physical site address locations throughout the United States. Weekly informal walkthroughs, which were instituted by Mr. Simpson, are continuously being practiced in each facility site to eliminate safety and health hazards immediately identified. This practice resulted to instill a behavior-based safety method establishing work safety as one with management, supervisors, and employees. These inspections also pioneered the Safety Health Achievement Recognition Program (SHARP) for each of their facility site locations. He also

coordinated to ensure that the Safety Committees employees be trained to identify safety and health hazards in the workplace. Seven out of ten facilities have earned gold or silver recognition certificates for having an injury or accident rate below or at the NAIC industry rate through Mr. Simpson's perseverance to impart the importance of safety in the institution to which he belongs.

Criteria for Nomination: Institution, company, training entity, individual, etc., with an above-average program of educational nature in the fields of environmental/occupational safety and health, fire science and safety, public safety, healthcare safety transportation safety, or similar programs; actively (and above average in) contributing to the protection of people, property, resources and the environment through innovative programs; with distinctive concern for the education of professionals and general public in the disciplines of safety and allied fields.

# **Discipline of Public Health and Tropical Medicine**

#### James Cook University, Queensland, Australia

With the numerous developments and innovations in the field of Public Health and Tropical Medicine, the Public Health and Tropical Medicine Teaching Leadership Team is thereby given the WSO Educational Award for their outstanding contribution and leadership in being able to completely redesign the MPH&TM course. This allowed more MPH&TM graduates to be fully equipped with the necessary skill set in both clinical and public health. The Public Health and Tropical Medicine Teaching Leadership Team paved the way to address the global challenges faced by people today, particularly those who are exposed in the tropics. Their continuous efforts and utmost diligence have been well-recognized by different bodies as illustrated in a number of reports including the United Nation's 2014 Millennium Development Goals Report (United Nations, 2014) and the 2014 State of the Tropics Report (JCU, 2014), which both highlight that while much progress has been made across a number of indicators, many significant and unique challenges remain in tropical regions particularly in the Oceania region in which many of Australia's closest neighbors reside. The MPH&TM has been offered at James Cook University since 1992 and has evolved to become one of the leading Public Health courses in Australia.

# **University of Benin Teaching Hospital**

#### Benin City, Edo State, Nigeria

University of Benin Teaching Hospital (UBTH) as a tertiary health facility came into being in 1973 following the enactment of an edict (number 12). As the sixth of the 1st generation Teaching Hospitals in Nigeria, it was established to complement its sister institution, University of Benin, and to provide secondary and tertiary care to the then Midwestern Region (now Edo and Delta States) and its environs. It also provides necessary facilities for training of high and middle level manpower for the health industry and spearheads research opportunities for lecturers in the University and other interested persons with local morbidity burden as research question(s). In 2012, UBTH co-sponsored the WSO National Office for Nigeria, making the institution an international supporter of the WSO motto, joining to: "Making Safety A Way of Life... Worldwide". In 2013, UBTH recorded Africa's first successful Sickle Cell Transplant. The Vice-Chancellor of the University of Benin, Prof. Osayuki Oshodin, who was represented by the Deputy Vice Chancellor, (Academics), Prof Emmanuel Onibare, commended the management of UBTH for the landmark achievement, adding that the university would continue to support the hospital in the realization of its objective. Through the Community Health Centers in Ogbona and Udo, and the General Practice Clinic that came on stream later, UBTH equally provides some avenues for primary health care to the immediate communities. At inception, its goals were encapsulated in the motto of Healing, Research and Training. Located on the Benin-Lagos Expressway and initially commissioned as a 300-bed hospital in 1973, UBTH has expanded facilities to over 500 in-patients. The vision of UBTH is to be a major player in health care delivery, research, and training in Nigeria and Africa at large. Their mission is to provide effective and efficient training of health professionals, quality research, and equitable service delivery with empathy toward their clients.

Selection is based on individual or group actions that significantly contributed to the effectiveness of the application of WSO programs in research and development.

Being the pioneer in innovating ideas on how to simplify complex activities for contractors to adopt operations along with effectively implementing various OHS&E training that benefit numerous engineers and a big population of the workforce, Mr. Kannan proves to be a forerunner in Scientific Research and Development. His discipline and hard work was well-recognized by the Government of Tamil Nadu, the Government of India, and the Japanese International Cooperation Agency (JICA) among others. Mr. Kannan's expertise is a product of over 20 years of experience in the field of Occupational Health, Safety & Environment along with a list of handling a wide range of high risk

activities in the public domain, which includes the mega construction of the Chennai Metro Rail in India.

Criteria for Nomination: Company or Corporation who is actively (and above-average) in contributing to the protection of people, property, resources, and the environment through innovative programs; shows distinctive concern for the well-being of its employees and local community.

#### **Energy Development Corporation**

#### Pasig City, Philippines

Energy Development Corporation (EDC) is a global and diversified renewable energy company and is currently the largest producer of geothermal energy in the Philippines. Due to the high level of potential health and safety risks that go hand in hand with the production and delivery of energy, adherence to the highest safety standards is a sustainability priority of EDC. All EDC employees and contractors in the Strategic Business Units are represented in their internal Health, Environment, and Safety Committee which covers the occupational safety and health programs of the steam field and power plant operations. The committee meets regularly, with monitoring systems in place to track the agreed health and safety action items and statistics, allowing the company to improve performance in terms of injury types and rates, occupational disease rate, lost days rate, absentee rate, and work-related fatalities, for the total workforce. In terms of third parties and external stakeholders, the company has a Contractor Health and Safety Management Program, which requires all contractor workers to attend and pass the Safety Passport Training before being allowed to work in EDC's operating sites. Last year, the company's Mt. Apo Geothermal Business Unit (MAGBU) received two safety milestone awards from the Department of Energy (DOE) for having no Lost Time Accident (LTA). Related to this, three (3) safety personnel received the DOE-SHAPES "2014 SHAPES Outstanding Safety and Health Professional Award." Also, the Department of Labor and Employment (DOLE) Region 12 awarded the "Safety Recognition Award" to the business unit as a result of its compliance and commitment in implementing plans and programs on occupational safety and health. To date, EDC aims to take safety programs up a notch by creating a generative safety culture, where safety and health are built into the way each and every employee works and thinks, and there is increasing trust and accountability in everyone.

#### **Petron Corporation**

#### Mandaluyong City, Philippines

Petron Corporation goes above and beyond providing oil requirements in most areas of the Philippines. Petron Corporation has achieved numerous milestones and distinctions from local government agencies for the year 2014. Depot & Plant Operations (DPO) achieved a significant safety milestone attaining Zero Loss Time Incident in all of Petron's 32 depots and terminals as well as posting a combined record of 60 Million Safe-Man-hours Milestone covering the whole division and its contractors on September 24, 2014. The total safe man hours for 2014 were 17,640,267. This figure is broken down into Petron Bataan Refinery (PBR) with 10,008,943 hours, DPO with 6,082,541 hours and Corporate Offices with 1,548,783 hours. With the annual safety programs being implemented by the company, Petron Corporation garnered four (4) awards and recognitions on the 9th Gawad Kaligtasan at Kalusugan (GKK) Awards on October 27, 2014. For the individual category, Rosario Depot Superintendent Joey P. Ortega proudly emerged as the Champion with Gasul San Fernando Superintendent Eusebio A. Timario, Jr. as the Bronze award recipients. Under institutional category, Legazpi Depot was given the Silver award while Rosario Depot received the Bronze award. Nasipit, Tacloban and Gasul San Fernando Depots also qualified as finalists for the institutional category. Rosario Depot, Davao Depot and Tagoloan Depot were the receivers of the Tripartite Certificate of Compliance with Labor Standards (TCCLS) for this year. Gasul San Fernando was also conferred the Child Labor Free Establishment (CLFE) Award and the Most Fire Safety Conscious Workplace for the second consecutive year. The GKK is a national award given every two years by the Department of Labor and Employment (DOLE) in recognition of outstanding achievements and best practices of establishments and individuals on safety programs. The GKK Award is one of the five DOLE good housekeeping certificates required to achieve the Tripartite Seal of Excellence (TSE). The other four certificates are the TCCLS, the CLFE, GKK, National Productivity Olympics Award, and the Outstanding LMC Award for Industrial Peace.

Among its distinctions are the highly-coveted PEZA Employer of the Year Award, PEZA Best Community Projects Award, and the PEZA Exporter of the Year Award.
