Under general direction, is responsible for coordinating and conducting audits, surveys, analysis and training in accordance with the Occupational Health & Safety Management System (OHSMS) program for the City of San Antonio Departments. Coordinates safety efforts with internal and external stakeholders to ensure compliance with applicable agencies standards, continual training and accreditation of the OHSMS program. Exercises no supervision.

- Assist with the oversight of daily self-inspections performed to meet established requirements and good means of identifying safety hazards in accordance with OHSMS program.
- Reviews and revises citywide OHSMS policies and procedures in accordance with changes to system standards and other regulations and new technological changes.
- Acts as a resource to and liaison between the Office of Risk Management and various departments with the City of San Antonio as well as external customers, and vendors related to safety issues.
- Provides recommendations in the enhancement to the OHSMS program.
- Prepares, and delivers reports, operation statistics, or industry studies. Makes oral and written presentation on programs, projects and other matters.
- Provides input to the annual Safety Division budget, training plan, and evaluation schedules.
- Assists in the design and delivery of safety education programs and communicates safety information and trends to employees and management on a regular basis as part of Safety Promotion.
- Attends meetings with various levels of management, external contacts, and regulatory agencies. Takes necessary action regarding agenda items.
- · Perform related duties and fulfills responsibilities as required.
