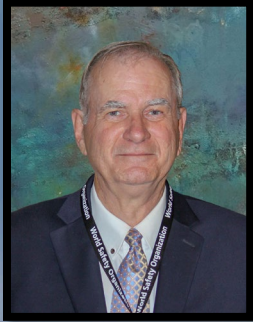

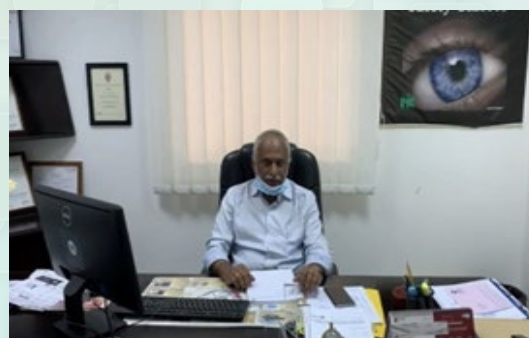

Speaker 1:

The first speaker, Engr. Dr. Kennedy Okafor, is the Chair R & D, linkages, and workshop series in the Mechatronics Engineering department at the Federal University of Technology, Owerri, Nigeria, and a senior researcher with the University of Johannesburg, South Africa. Kennedy is a Senior Member of IEEE, USA; a teaching researcher with over 15 years of R & D experience in Robotics, Advanced Computing, Scale Agile-Scrum designs, Data Center Automation, Big Data Analytics, AI, Mechatronics Applications, and Cyber-security to date. He spoke on "Leveraging AI Powered Robots in Building Resilient Occupational Safety and Health System." In his presentation, he looks at:

- New opportunities to raise awareness and stimulate dialogue on the importance of creating and investing in resilient OSH system
- Need for resilient OSH for future emergencies/pandemic

In practical terms, he revealed the achievements so far made to include the development of a Covid-19 marketplace robot that uses vital signals to detect, prevent and mitigate the spread of the disease in Nigeria hospitals.



Speaker 2:

Jamiu Badmos (COREN, MNSE, IAEng, MIET) is a versatile, analytical and passionate QHSSE Professional, Business Sustainability Executive and an International Vision Zero Trainer with over 20 years practical hands-on approach, strong coaching skills, high decisional-efficiency and International certifications in Environmental Law, Quality, Health, Safety, Security, Environment, Business Continuity, Business Process, Enterprise Risk Management, Asset Management and ISO Management System Standards. As a registered Engineer with innovative ideas to deliver tasks meticulously, timely and passionately, he has translated excellent safety, environmental and quality performance into profitability and operational excellence for over forty-five (45) companies including Multi-nationals in Oil & Gas, Telecoms, Manufacturing, Banking, Logistics, Construction and Power sectors of the economy.

On the topic "Reimagining the Future; Leading through Crises," Engr. Badmos looked at the roles of purposeful leadership during a crisis. In his presentation, he stated emphatically that "the real test of leadership does not occur when everything is smooth sailing; but rather, leadership is often times tested during a crisis." He went ahead to highlight the 5 leadership keys to navigate through crises as follows;

1. Build trust by asking your team about their state of mind.
2. Adapt your communication style to develop resilience.
3. Create routines to manage stress.
4. Keep team spirit alive and innovative.
5. Develop your own leadership to lead others

Amb. Adebisi Adewale is the MD/CEO of Crownbondis Global Resources Limited. He is a seasoned Health, Safety and Environmental Consultant with vast experience in the aforementioned field, home and abroad. Involved in the formulation of policies for regulatory bodies, giving advices as a Consultant middleman between the regulators and operators in diverse industries; also, an advocate of sustainable environment and a well sort after HSE Trainer. In his presentation captioned **“Emergency Response and Preparedness.”** He elaborated on the scope of ERP consideration to include flood, security issues, hazardous materials incident, fire, building collapse and natural disasters, he goes further to list the mandatory elements in a good Emergency Response Plan. He stated that an ERP must have the following elements:

- Identify hazard and assess risk.
- Assess capabilities and resources.
- Develop an emergency plan and procedure.
- Integrate the plan with the community plan
- Conduct training.
- Public relations.
- Conduct drills and exercises
- Develop plan audit procedure.

Unveiling of the revised Occupational Safety & Health (OSH) Policy by the Honourable Minister of State for Labour & Employment. Mr. Festus Keyamo SAN in commemoration of the 2021 World Day for Safety & Health 2021.

As part of her role as a consultative stakeholder, WSO Nigeria have also been playing vital roles with the Federal Ministry of Labour and Employment under the Department of Occupational Safety and Health (OSH) and Factories act in Nigeria to upgrade Safety laws and standards in Nigeria. To this effect she was a part of the Launching and unveiling of the revised Occupational Safety & Health (OSH) Policy which took place in Abuja, Federal Capital territory of Nigeria on the 28th of April in commemoration of the World Day for Safety & Health 2021.

The objectives of the Nigerian OSH Policy is:

- To provide a general framework for the improvement of working conditions and the working environment.
- To promote safety, health and wellbeing of workers in workplaces by minimizing accidents and departures from health arising out of or in the course of work, including emerging risks and concerns.
- To reduce occurrences and incidences of accidents, work-related diseases / illnesses, injuries and fatalities.
- To ensure the provision of high-quality Occupational Safety and Health (OSH) Services and practices that are independent, impartial and accessible to all.
- To provide Occupational Safety and Health Services in all sectors that will enhance workers' productivity and economic growth.
- To provide suitable Occupational Safety and Health preventive programs and services including timely rehabilitation services.
- To set standards for processes, procedures and evaluating compliance with standards.

In his speech the Minister of state for Labour and Employment in Nigeria, Mr. Festus Keyamo (SAN) reinstated Occupational Safety and Health as a multidisciplinary field embracing specialized professional services rendered by Federal Ministry of Labour and Employment, Federal Ministry of Health, Federal Ministry of Environment, Federal Ministry of Petroleum Resources, Fire Service and other relevant governmental and non-governmental agencies. Thus, the need for a safety guideline which will serve as a practical tool that will help in identifying the strengths and weaknesses in the National Policy on Occupational Safety and Health so as to:

- Guide employers, workers and their organizations to implement the National Policy on Occupational Safety and Health. Provide practical information on the implementation of Occupational Safety and Health Policy and programs. Provide examples of best practices on how to respond to the emerging issues in Occupational Safety and Health.

The minister for state then proceeded to unveil and officially launch the revised OSH Policy. Each stakeholder present was given a copy of the OSH Policy and a Poster to display for press men to Publicized and extra copies were issued to take back to their organizations to implement.



In his good will message, the WSO Nigeria Administrator & Representative for Abuja, FCT, **Mr. Emmanuel Abayowa** who ably represented the Country Director **Mr. Soji Olalokun**, delivered the WSO President's speech. He also carried out an investiture of the WSO SafeER Ambassador on the newly appointed Director of Occupational Safety & Health and factories Act, Ministry of Labour and Employment, **Mrs. Lauretta Nneka Adogu**.

Responding to the investiture, Mrs. Adogu who admitted it came to her as a surprise, specially thanked WSO Nigeria for their continual support of making safety a way of Life worldwide and

also for their tireless contributions as stakeholders of the Federal Ministry of Labour & Employment. She promised to do more in the world of safety and also involve WSO Nigeria in their activities the more as the need arises. The SafeER Ambassadoral Medal and lapel was presented to her by the Deputy Director, Abuja Office of the Nigeria Employers' Consultative Association (NECA) Mrs. Adenike Ajala - Adebayo. NECA is the umbrella organization of employers in the Organized Private Sector of Nigeria. Also present at the occasion were the Permanent Secretary, Ministry of Labour and Employment Dr. Yerima Tarfa. The program ended around 4pm with a closing prayer of the second standards of the Nigerian National Anthem.

Remote Safety Inspections: The New Alternative to Conducting In-person Safety Inspections During the Pandemic and Beyond?

As we all know under the OSHA ACT the requirement for workplace inspections is a legal requirement. The need for these workplace inspections is also a necessary part of our effective safety programs. The use of routine workplace inspections have been proven over time to have positive impacts on identifying existing and potential hazards in the workplace. As Safety professionals we then take this data and utilize it to correct hazards in house and make sure they do not happen again.

Safety professionals utilize workplace audit data to implementing controls, such as elimination, substitution, engineering controls, administrative practices, and personal protective equipment for the workplace. Inspections also allow workers to discuss their concerns about safety. With the pandemic this simple normal task has become a major concern for both the construction and industrial workplace, with limited travel and minimal staffing concerns. Remote inspections can be an alternate and effective way to conduct a safety inspection not just during the pandemic but also in the future.

With the use of tablets and smart phones a single safety professional can walk an entire site with an employee, group of employees, and site leadership without even leaving their office or home! The most interesting part is that it doesn't have to be a costly expense. For example, a safety professional and an employee can take iPhone and face time while doing the workplace inspection. The safety manager would be able to actively see the site through the camera as the employee walks the site. No bulky computes or tablets, you can snap a picture on the phone for reference and keep moving through the worksite audit.

On the same note we do now also have apps and software that can also be added to tablets or other smart phones where you can have a virtual inspection the same way. With the technology growing in the industry and the need to continue to conduct safety audits with limited resources, security, safety, or physical limitations, the use of alternative methods is a must! A remote inspection can be an effective alternative and a learning experience for the rest of the Team involved in the audit process.



Is Your Worksite Lighting Meeting OSHA Standards?

OSHA's illumination standards for construction (29 CFR 1926.56) and shipyard employment (29 CFR 1915.82) are intended to ensure that specific work areas or areas where workers are stationed or passing through are provided with lighting that is sufficient to enable the workers to see hazardous conditions and avoid injury. The standards set minimum lighting requirements in terms of foot-candles, a term that has been somewhat indistinct for employers and one that OSHA itself has acknowledged does not provide clear direction on how much light is needed for specific tasks.

What Is a Foot-Candle?

A foot-candle is the amount of light generated by a single candle that falls on a single square foot of surface no more than a foot away from the candle. While the term continues to be used in OSHA's standards, lighting professionals consider it out of date, and it has generally been replaced by more precise terms, such as lumen and lux. A lumen measures the total amount of visible light emitted by a given source. Lux is used to measure the amount of light output in a given area.

Construction

OSHA's standard is brief, stating simply that listed areas of construction must be illuminated by a minimum number of foot-candles. Specifically:

- General construction—5 foot-candles
- Concrete placement, excavation and waste areas, access ways, active storage areas, loading platforms, refueling, and field maintenance areas—3 foot-candles
- Indoors (warehouses, corridors, hallways, and exits)—5 foot-candles
- Tunnels, shafts, and general underground work areas—5 foot-candles (exceptions apply to underground drilling, mucking, and scaling where 10 foot-candles are required. Cap lights approved by the Bureau of Mines are acceptable for use in the tunnel heading)
- General construction plants and shops (e.g., batch plants, screening plants, mechanical and electrical equipment rooms, carpenter shops, and workrooms)—10 foot-candles
- First-aid stations, infirmaries, and offices—30 foot-candles

Measurement

Neither standard addresses how to measure foot-candles or lumens for the purpose of compliance, e.g., the amount of light on a work surface. However, in a [letter of interpretation](#) from 1991, OSHA states that the existing illumination level at any work surface within a worksite is best measured with a light meter reading in lumens per square foot, which are equal to foot-candles. That advice remains relevant to OSHA's illumination standards
